CITY WIDE CLEAN UP IS THE WEEK OF

APRIL 17TH TO THE 22ND

The City will be offering a FREE OPTION, for the 2017 Spring Clean-up. A dumpster will be placed at the City dump, if you live inside Casey City limits and sign up with the City clerk, you can take advantage of this great opportunity!

You can bring your **GENERAL GARBAGE** to the City dump, FREE OF CHARGE

Monday April 17th to Friday April 21st Noon to 4pm.
Or Saturday April 22nd from 8am to 4pm.



You must sign up and PAY any fees with the city clerk before noon, Friday April 14th.

There will be a charge for any Brown Goods (appliances with Freon), White Goods (appliances without Freon), tires, TV's and computer monitors. These items will need to be placed at your curb side and will be picked up throughout the week.

If you prefer to have your general garbage picked up at curb side, there is a \$25.00 fee and the City Crew will pick it up during clean-up week.

Brown Goods (Appliance with Freon).....	\$15.00
White Goods (Appliances without Freon)	\$5.00
Car tires off rim.....	\$3.00
Car tires on rim.....	\$6.00
Truck tires off rim.....	\$12.00
Truck tires on rim.....	\$17.00
TV and Computer monitors under 21"	\$15.00
TV and Computer Monitors over 22"	\$30.00

With the City wide Clean up coming up, the Casey City Council would like to take this time to point out some of the **most common** City Code violations. The City Council is working diligently to get nuisances cleaned up. Please do your part to help beautify Casey.

- ✓ Dense growth of all weeds, grasses, vines, brush, or other vegetation in the City so as to constitute a health, safety, or fire hazard including any City owned property between the abutting property line and the street right-of-way. Grass height shall be no taller than 8-inches.
- ✓ Allowing accumulations of rubbish or trash tending to harbor vermin, rodents, and rank growth of weeds or other vegetation and plants, which is conducive to hazard, on a property.
- ✓ Storage of junk or abandoned vehicles. It is a violation to allow the parking, leaving, or storage of a junk vehicle upon either public or private property within the corporate limits of the City. And constitutes as a threat to the health and safety of the citizens and is a nuisance within the meaning of Section 657.1 of the Code of Iowa. If any junk vehicle is stored upon private property or public property in violation thereof, the owner of the property shall be liable for said violation.
- ✓ Dilapidated structures that have safety hazards, structural deficiencies, fire damage or other obsolete characteristics.
- ✓ Any vehicle that is 5 tons or more – parking is not permitted on any City street or public right of way.
- ✓ All dogs and cats over the age of 6 mos. is to have a pet license and tag, with the city, each year.
- ✓ All dogs and cats are to have pet's tags on the pet, or is considered non-licensed.
- ✓ Dogs are not to run at large at any time.
- ✓ Parking vehicles that block or obstruct an alley or drive way is not permitted.
- ✓ Parking on a city street for more than 24 hours is not permitted.
- ✓ No parking on sidewalks is not permitted

The City Council appreciates those that have and are currently are working on cleaning up nuisances. Each one has been noticed in a positive way.
