#### PET LICENSE DUE

Between Jan. 1 and March 1

Per City Code 4-1-2 any Dog or Cat over the age of 6 mos. is to be registered with the city.

A penalty of \$5.00 per animal, will be applied after March 1st

Every Dog and Cat are to be license regardless of age or if it goes out side out not.

Dog - \$15.00 each, unless spayed/neutered \$5.00

Cats- \$15.00 each, unless spayed/neutered \$5.00

\*\*Proof of spayed/neutered as well as current vaccinations are required before a tag/license will be issued\*\*







### Per City Code 3-3-33

Snow Ordinance is in effect from November 1<sup>st</sup> to April 30<sup>th</sup> each year.

Do not leave vehicles parked on City Streets, City right of ways, and City owned off street parking during which time snow and ice is forecasted and in process of being removed.

Offenders' vehicles can ticketed or towed away at their expense.

### Per City Code 3-1-4

No abutting property owner shall allow water, snow, ice and accumulations on sidewalks, must be removed promptly after a snow event.

Cost and fines may apply if not removed promptly.

Per City Code There is to be
NO PARKING ON OR BLOCKING
SIDEWALKS, at any time and anywhere.
If you are currently parking or blocking a portion of a sidewalk, please find alterative parking. Fines may apply.

## Q&A: Mail Delivery During and After Major Snowstorms

1. What are the general rules for a carrier's accessibility to a mailbox?

During and after a storm the Postal Service employees will make every reasonable, safe attempt to deliver mail to the addressee

For successful mail delivery during and after storms, we ask for the cooperation of our customers so that our employees return home safe at the end of each work day. Carriers are not required to deliver to locations where safety issues — such as icy steps, snow-packed paths or icy overhangs — create perilous conditions. Some things to consider:

- Painted porches and steps are particularly hazardous. While salting or rubber-backed mats help make them less slippery, we rely on our customers to clear the snow before a letter carrier arrives with the mail.
- Keeping your steps and sidewalk clear of snow and ice as well as removing snow from around curbside mailboxes — allows us to provide you with the safest, most efficient service possible
- In those situations when delivery is suspended, we look for the customer to contact local postal officials to discuss ways to eliminate the hazard. Sometimes we are able to offer suggestions that help restore delivery quickly.
- Slips, trips and falls are the leading cause of accidents among letter carriers. In
  addition to the safety of the carrier, injuries to a letter carrier or <u>any</u> visitor to your home
   can result in costly liabilities to homeowners.
