Casey Regular City Council Meeting Casey Community Building August 3, 2020

The Casey City Council held a regular meeting on Monday, August 3, 2020. Mayor Nicholas Lindberg; Councilmembers Rick Richter, Stacy Wagner, Larry Chmelar, and Leland Acker were present, Bret Wedemeyer arrived at 7:10 pm; also present were City Clerk Gwen Blass, Public Works Director Jon Welker, Tim Knapp, and Attorney Clint Fichter.

Mayor Lindberg called the meeting to order at 7:00 pm. All rose to say the Pledge of Allegiance. Motion by Chmelar second by Richter to approve the agenda; ayes - Richter, Wagner, Acker and Chmelar, absent - Wedemeyer. Motion by Wagner second by Chmelar to approve the consent agenda including the, 7/6/20 minutes and July bills; ayes - Richter, Wagner, Acker and Chmelar, absent - Wedemeyer.

Blass provided a written clerks report, also reporting that an extension for the W Thomas/Russell St FEMA project was filed and approved, trees need to be ordered for courtyard from GCCF grant, researched whether a sign grant was summited, Jon informed that there is no current need for new signs or posts, and discussed designation of a one way alley. Wagner inquired about stop sign on McPherson. Blass has a call into IA DOT to find out requirements for placing a new stop sign.

Welker provided the public works report informing council of a broke down blower at the sewer plant. Jon received a quote from JC Cross Co for \$3313 plus \$1800 installation for a new blower. Motion by Wedemeyer second by Richter to purchase pump from JC Cross Co.; all ayes. Water levels are dropping due to multiple leaks and drought. Jon requested a water conservation alert. Motion by Wagner second by Wedemeyer to initiate a water conservation order to stop watering lawns and gardens, no filling swimming pools or any unnecessary water use; all ayes. Jon suggested pursuing a grant to drill a new well, council asked clerk to look into possible grants.

Mayor Lindberg announced the Adair Co. Landfill is hiring, updated council regarding nuisances, and informed council approval was given for public works overtime while fixing water leaks. Mayor did not receive updated bid for ADA door opener. Acker stated received an estimate to tear down 705 Russell St house for \$5000 to \$8700. Blass stated that the Derelict Building Grant was only for commercial building not residential.

Chmelar received a bid from Automatic Door Group for \$2300 and will get additional information regarding shut off process.

Motion by Wedemeyer second by Richter to approve 2020 Outstanding Obligations Disclosure Statement Report; all ayes. Council requested clerk to check on refinancing for a better interest rate.

Motion by Richter second by Acker to adjourn at 8:10 pm; all ayes.
